There will be 30 employees not including 15 registered NYS Security Guards stationed at key points throughout the premises and at the door. No one under 21 years of age will be admitted. Identification will be required before entering. Application states a relationship has been established with police. Manager, Rouslan Gavine, is the manager of current tenant, "Show Palace". Mr. Gavine will run the day to day operations from 7pm to 4am approximately 60 hours a week, 5-6 days per week.
