The first floor is made up of a kitchen, storage room, closet, lockers, mechanical room, 4 restrooms, an 85' U-shaped bar. There is a raised runway that is 17'6" distance from the perimeter of the bar. Seating provided around the bar as well as tables, bench seating and couches. One area of the mezzanine leads to 5 party rooms with the diagram indicating clear glass. The other mezzanine leads to alcohol storage, employee lounge, Lighting & Sound Control Center, office, restroom and closet. The premises will have 1 stand-up bar and 1 service bar.

Method of Operation: Premises will operate as a bar serving liquor, wine and beer and providing adult entertainment.
