The applicant signed the Community Board stipulation and has agreed to all conditions.

Description of Premises: The premise is located on the first floor of a five story building with apartments above. Premise consists of dining area with 5 tables with 15 seats, 2 bathrooms, and 1 stand-up bar approximately 25' long with 12 stools located on the right side of the premise.

Method of Operation: Bar/tavern with art exhibition space serving liquor, wine and beer, 4 employees, no dancing, recorded music and principals to manage.
