## Description of Permits and Instructions

### **ALCOHOLIC BEVERAGE EDUCATION PERMIT - \$270 (Annual Permit); \$25 (1 Day Permit)**

**Complete pages 1 through 4 and attach the course curriculum. Be sure to select the correct type of permit and complete the signature sheet.** This application is to be used by a person conducting a class or seminar designed to increase participants' knowledge and appreciation of wine and/or other alcoholic beverages. Such permit shall allow the participants of the class or seminar to imbibe or taste such alcoholic beverages. The permit does not allow for the solicitation of orders or sale of alcohol. The permit is available for either a one day or twelve month period.

### **CRAFT BEVERAGE TASTING EVENT PERMIT - \$ 36**

**Complete pages 1 through 3. Be sure to select the correct type of permit and complete the signature sheet.** This application is to be used by a not-for-profit organization conducting an event where alcoholic beverage manufacturers or wholesalers will be providing samples and/or selling their products and where the not-for-profit is charging attendees. If there is no charge to a person to attend the event, the not-for-profit organization does not need to obtain a permit. The not-for-profit organization is responsible for making sure that all attending manufacturers and wholesalers have the proper permit to participate in the event. Only one permit is needed for each day of an event, regardless of the number of manufacturers and/or wholesalers participating in the event.

### **DISTRIBUTOR'S ALCOHOL PERMIT (A, B, C, D)**

**Complete pages 1 through 3. Be sure to select the correct type of permit and complete the signature sheet.**

Class "A" Permit, Fee - **\$4,820.00** (3 years) shall authorize the holder thereof to sell and distribute to licensed rectifiers alcohol which is to be used for beverage purposes and to all holders of permits issued pursuant to §91, §92, and §92-a of the Alcoholic Beverage Control Law.

Class "B" Permit, Fee - **\$2,420.00** (3 years) shall authorize the holder thereof to sell and distribute alcohol to holders of a class "C" alcohol distributor's permit or to holders of permits issued pursuant to §91 and §92 of of the Alcoholic Beverage Control Law.

Class "C" Permit, Fee-**\$500.00** (3 years) shall authorize the holder thereof to sell and distribute alcohol to holders of permits issued pursuant to §92 of of the Alcoholic Beverage Control Law, and to use alcohol in the preparation by him of any of the products enumerated in §91. Such a permit may be applied for by and shall be issued only to a wholesale druggist.

Class "D" Permit, Fee- **\$1,172.00** (3 years) shall authorize the holder thereof to sell and distribute alcohol to the holder of winery licenses. Such permit shall be issued only to a person holding a winery license under of the Alcoholic Beverage Control Law.

### **HOME WINE MAKING CENTER PERMIT - \$145**

**Complete pages 1 through 3 and page 5. Be sure to select the correct type of permit and complete the signature sheet.** This application is to be used by wineries and farm wineries to operate a "home wine making center" where the permittee provides to individuals, for a fee, ingredients and equipment for the production of wine for that individual's personal household or family use and not for resale in accordance with federal law, rules and regulations that authorize the production of wine for household personal or family use and which wine is deemed tax exempt by the Federal Alcohol and Tobacco Tax and Trade Bureau.

**RETAIL BEER FUNCTION PERMIT (ANNUAL)- FEE - \$ 74.00**

**Complete pages 1 through 3. Be sure to select the correct type of permit and complete the signature sheet.** This application is to be used by a Brewer or Beer Wholesaler for the issuance of an Annual Beer Function Permit, pursuant to §97.2 of the Alcoholic Beverage Control Law, to authorize the sale of beer for consumption only and not for resale, at outdoor or indoor gatherings, functions, occasions or events to which the general public will not be admitted and to which admission is not made contingent upon the payment or an admission fee, donation or contribution. Any person who purchases beer for consumption at the gathering must execute and file with the permittee a statement that the beer will not be re-sold or offered for sale.

**WINE PRODUCTS PERMIT- \$165 (Large City); \$83 (All Other Locations)**

**Complete pages 1 through 3 and page 6. Be sure to select the correct type of permit and complete the signature sheet.** Permission is granted to the licensee hereafter designated under § 79-a and §79-b of Alcoholic Beverage Control Law, to sell Wine Products as defined in §3(36-a) of the Alcoholic Beverage Control Law. Premises located in a city with a population of 100,000 or greater will be subject to a higher fee.

**AFFIDAVIT IN SUPPORT OF THE APPLICATION FOR AN ALCOHOLIC BEVERAGE EDUCATION PERMIT**

In order to induce the New York State Liquor Authority to issue the applied for permit , the undersigned stipulates that the applicant understands and will comply with each of the following conditions for the duration of the permit:

- 1) All participants in such class or seminar will be at least twenty-one years of age;
- 2) The participants' imbibing or tasting of such alcoholic beverages are a part of the class or seminar;
- 3) The permittee does not hold any license issued under the Alcoholic Beverage Control Law;
- 4) No tasting of alcoholic beverages shall take place during the hours prohibited by the provisions of ABCL §106(5);
- 5) The curriculum and location for such class or seminar must approved by the License Board;
- 6) The permittee will not solicit or accept orders for alcohol; and
- 7) The permittee will purchase all alcohol products for used in the classes/seminars from licensed manufacturers, licensed wholesalers or private collections.

**AFFIDAVIT IN SUPPORT OF THE APPLICATION FOR A WINE PRODUCT PERMIT**

In order to induce the New York State Liquor Authority to issue the applied for permit , the undersigned stipulates that the applicant understands and will comply with each of the following conditions for the duration of the permit and all renewals:

1. The applicant must hold a base retail beer license to operate a grocery store, a drug store, or an eating place; and the premises licensed must be open and operating.
2. This Wine Product Permit will only remain valid so long as the base license remains in effect.
3. The sale of wine products under the permit shall be subject to the same rules, restrictions and conditions, as apply to the base retail beer license.
4. The permittee shall present the permit for inspection upon demand by any peace officer, law enforcement, or any duly authorized representative of the Liquor Authority.
5. Said permit shall be placed on display at all times next to base retail beer license so that it will be plainly visible.
6. Sale of wine products to anyone under the age of twenty-one is prohibited and may subject the permittee to revocation of both the Wine Products Permit and base retail beer license .
