



APPLICATION FOR A TEMPORARY PERMIT OR EXTENSION OF A TEMPORARY PERMIT FOR A WINERY OR FARM WINERY (FP 306)

Section 76-b authorizes the issuance of temporary winery and farm winery permits. The initial permit is valid for a six (6) month period. The fee for the initial permit is \$125.00, which is deducted from the winery or farm winery license fee. If the temporary permit application is submitted at the same time or after the wholesale application is submitted, then no additional fee is required. If the temporary permit is applied for before a wholesale application is submitted, then the \$125.00 fee is required with the permit application, but will be credited toward the winery license fee.

The temporary permit can be extended for a three month period, at the Authority's discretion, for an additional \$50.00 and with the submission of this application form.

YOU ARE ELIGIBLE FOR THIS PERMIT IF:

- (a) you have a winery, farm winery, special winery, or special farm winery license application pending before the liquor authority, and the beginning of the harvest season for grapes or any other fruit or product necessary for the production or manufacture of wine at that facility will occur within thirty days; or
- (b) you are in good faith negotiations with or have entered into an agreement with a winery, farm winery, special winery, or special farm winery licensee to purchase, obtain or acquire part or full ownership rights in the assets or stock of such existing licensee; or
- (c) due to unforeseen circumstances or an emergency situation, you are in need of a permit to ensure the continued or future operation of an existing winery facility.

A temporary winery or farm winery permittee can perform the same activities that a winery or farm winery licensee is allowed

I understand that failure to give such notice may result in disapproval of the application or revocation or non-renewal of any license for which this application is submitted; and

I understand that the licensee will be bound by the statements and representations made in the application, including, but not limited to the licensee's method of operation and the identity of persons with an ownership or financial interest in the licensed premises; and that all statements and representations made become conditions of the license; and

I understand that any physical alterations to, or changes to the size of the area used for the sale and consumption of alcoholic beverages, must be reported to the Authority and may require the approval of the Authority; and

I understand that the licensee must keep the Authority advised of any change in the mailing addresses of the licensee, the licensee's principals, and the licensee's landlord.

I understand that the licensee's failure to operate the licensed premises in accordance with the statements and representations made in the application may result in revocation of any license for which the application was submitted; and

I understand that any false statement or misrepresentation will constitute cause for disapproval of the application or revocation or non-renewal of any license for which this application is submitted.
