

TRANSPORTATION PERMIT TERMS AND CONDITIONS

FLEET TRUCKING

Pursuant to Section 94(2-a) of the ABC Law.

This permit authorizes the permittee to transport alcoholic beverages in any and all vehicles owned or hired, and operated by the permittee within this State; to transport alcoholic beverages from within NYS to points outside NYS and to transport alcoholic beverages from outside NYS to points with NYS. A fleet permit allows the licensee to register all vehicles under a blanket permit without having to provide detailed information on each vehicle and allow adding and removing of vehicles without notification to the State Liquor Authority.

The following documentation must be submitted with the application:

- 1. Authorization Form**
- 2. \$1,000 penal bond**

FLEET COMPANY

Pursuant to Section 94(2-b) of the ABC Law.

This permit authorizes a licensed manufacturer or wholesaler pursuant to Section 53 of the ABC Law a company permit to cover any and all vehicles over sixty-five thousand pounds hired or contracted for a term. In lieu of the sign required to be affixed to each vehicle the holder of the company permit may have in the cab of such hired or contracted vehicle a copy of the permit, noting the time and date alcoholic beverages departed the company and is intended delivery time and date of destination of its company permit issued by the Authority.

The following documentation must be submitted with the application:

- 1. Authorization Form**
- 2. \$1,000 penal bond**

TRUCKING

Pursuant to Section 94 of the ABC Law.

This permit authorizes the permittee to transport alcoholic beverages within New York State; to transport alcoholic beverages from within New York State to points outside the state; and to transport alcoholic beverages from outside the New York State to points within the state.

The following documentation must be submitted with the application:

- 1. Authorization Form**

2. \$1,000 penal bond

AIRCRAFT (One Time and 3 Year)

Section 99(b)(1)(b) of the ABC Law.

This permit authorizes an aircraft company to purchase alcoholic beverages from a duly licensed manufacturer or wholesaler for consumption outside the territorial jurisdiction of New York State.

This permit is subject to the following conditions:

- 1. The alcoholic beverages will not be offered for sale or sold in this state.**
- 2. A copy of the permit will be delivered to each manufacturer or wholesaler from whom purchases are made.**
- 3. The alcoholic beverages will be delivered directly to the aircraft of the permittee or to a warehouse for which a warehouse permit has been issued by the Liquor Authority.**
- 4. Only alcoholic beverages in the original sealed containers which comply with the provisions of law with respect to labels and sizes of containers will be purchased.**
- 5. Applicant must own and operate or charter and operate the aircraft.**

STEAMSHIP (One Time and 3 Year)

Section 99(b)(1)(b) of the ABC Law.

This permit authorizes a steamship company to purchase alcoholic beverages from a duly licensed manufacturer or wholesaler for the ship's stores for consumption outside the territorial jurisdiction of New York State.

This permit is subject to the following conditions:

- 1. The alcoholic beverages will not be offered for sale or sold in this state.**
- 2. A copy of the permit will be delivered to each manufacturer or wholesaler from whom purchases are made.**
- 3. The alcoholic beverages will be delivered directly to the steamship of the permittee or to a warehouse for which a warehouse permit has been issued by the Liquor Authority.**
- 4. Only alcoholic beverages in the original sealed containers which comply with the provisions of law with respect to labels and sizes of containers will be purchased.**
- 5. Applicant must own and operate or charter and operate the steamship for which it will purchase alcoholic beverages for the ship's store.**
