This application is to be used by a railroad company to apply for a license to sell liquor, wine and beer at retail for consumption on a RAILROAD CAR or TRAIN.

The original of this application must be properly executed and signed and mailed to: **New York State Liquor Authority Licensing, Church Street Station, PO Box 3817, New York, NY 10008-3817.**

- (1) CERTIFIED CHECK, BANK OFFICER'S CHECK or DRAFT, or MONEY ORDER payable to the State Liquor Authority for the required fee for each car for which license is sought. (\$384 license fee + \$200 filing fee = \$584).
- (2) BOND in the penal sum of \$1000, issued by a surety company authorized to execute such bonds in the State of New York, for each railroad car license applied for under Option C.
